For the fourth year in a row, Henry County Water has the Plant of the Year in Georgia

For the fourth straight year, the Henry County Water Authority (HCWA) has the best wastewater plant in the state, with the 2014 honors going to the Bear Creek Water Reclamation Facility in Hampton.

During its recent Spring Conference, the Georgia Association of Water Professionals (GAWP) recognized Bear Creek with the Plant of the Year Award for facilities with 1 to 10 million gallon per

day (MGD) of wastewater treatment capacity.

In addition, the Bear Creek and Indian Creek Water Reclamation Facilities won GAWP Gold Awards for 100 percent permit compliance this past year, while the Walnut Creek Plant won a GAWP Platinum Award for five consecutive years of no permit violations.

On the water side of HCWA operations, the Authority's Tussahaw and Towaliga Water Treatment Facilities both won Platinum Awards as well, but for seven straight years of 100 percent permit compliance. The HCWA also won the award for Best Tasting Drinking Water in Georgia's District 3, prior to coming in third in the statewide competition among all district taste test winners.

Also during the GAWP Spring Conference, the Authority's Stan Stanley received the "Top Op" Award, given to the best wastewater plant operator during the year, in the state's District 3. And the Authority's Nic Spann narrowly defeated fellow HCWA employee Brook Jackson to win the state Meter Madness competition, which tests who can assemble a residential water meter in the fastest time. Spann did so in just under 35 seconds.

The GAWP Plant of the Year Award for Bear Creek marks the fourth time in as many years that the HCWA has boasted the state's best wastewater

plant. Bear Creek also was a Plant of the Year winner in 2012, sandwiched between the Indian Creek Water Reclamation Facility's award in 2011 and the Walnut Creek Plant's honor last year.

Some tips to help you find and fix a leak

Henry County Water Authority employees made their annual pilgrimage in March to The Home Depot and Lowe's in McDonough to offer tips on wise water use and leak detection for store customers.

The Authority celebrated national Drinking Water Week with in-store displays and demonstrations at both home improvement stores. The Home Depot and Lowe's sponsored a drawing for the HCWA to give away a free water efficient toilet to a lucky customer, who stopped by the HCWA booth during Drinking Water Week to learn more about how to save water and money by finding and fixing household leaks.

In order to continue wise water use, consider the following process for locating leaks at your home or property:

- Turn off all water inside and outside the house.
- Remove the meter box lid and watch the meter.
- If the triangular black or red "flow indicator" is spinning while the water is turned off, you have a leak.
- If the indicator is not moving, check it again in 10 minutes to see if it has moved, and if so, you have a slow leak.

- Locate the main shut-off valve in your house and turn it off.
- Turn on a faucet inside the house, and if it continues to run after several seconds, the shut-off valve is not working.
- If water eventually stops running from the faucet, return to the meter and check again to see if the flow indicator is moving.
- If the indicator or dial hand is moving, water is still flowing between the meter and the shut-off valve, so your leak is likely underground.
- If the indicator is not moving, then your leak is likely indoors.

To test for a leak at the most common point in the home – each toilet – place water based food coloring (to prevent from discoloring the inside of your toilet) in the back of the toilet tank. After 15 to 20 minutes, check to see if water in the toilet bowl has changed colors. If so, you have a "silent leak" in your toilet, so make sure necessary parts are replaced.

Pay by Automated Draft

Have your payment automatically debited from your checking or savings account each month. Applications for automated/direct bank draft service are available on our website at www.hcwsa.com or by calling our Customer Service Department at 770-957-6659.

Pay Online

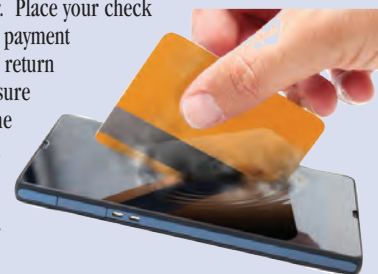
You also can pay your bill online when registering and logging onto your account on our website (www.hcwsa.com), which then allows you to check your balance and pay by credit card (MasterCard/Visa or debit card).

Pay by Phone

Call our Customer Service Department at 770-957-6659 to pay by credit card (MasterCard/Visa or debit card) over the phone.

Pay by Mail (Check or Money Order)

You can pay your bill by regular mail, using a check or money order. Place your check or money order and the payment portion of the bill in the return envelope provided. Be sure to include your telephone number, with area code, on your check to ensure prompt and accurate posting of your payment.

Finally, you can pay your bill in person at the HCWA headquarters at 1695 Highway 20 West in McDonough, during our business hours of 8:00 a.m. to 4:30 p.m. Be sure to bring your bill for prompt and accurate posting of your payment. Payments are accepted at the customer service counter, at our drive-thru window, or via our night depository. (Please, no cash payments in the night drop box.)

Henry County Water celebrates Earth Day with Cubihatcha Cleanup

Approximately 30 volunteers took part in the first Henry County Water Authority (HCWA) Earth Day Cleanup at the Cubihatcha Outdoor Education Center on April 19, a few days prior to the global celebration of Earth Day on April 22.

The volunteers, consisting of HCWA employees, family members and friends, braved cold and drizzly weather to spruce up the public use facility and clear an estimated two miles of brush and storm debris from the long/river trail that runs between the Upper and Lower Towaliga Reservoirs.

The Cubihatcha Center is the focal point of outdoor education

and public recreation provided by Henry County Water. Thousands of guests visit the Center annually for school field trips, fishing and hunting events, as well as group outings to the campus, which features an interpretive center, meeting room, outdoor classrooms, two constructed trails, and the HCWA Reservoirs Office.

The Cubihatcha loop trail is two miles in length and open to the public year-round. The long/river trail typically is open

from April to October, though construction of the bridge at Highway 155, coupled with storms that have damaged boardwalks along the route, have caused the Authority to close this amenity temporarily. Authority officials hope the Earth Day Cubihatcha Cleanup will go a long way toward allowing the Center's staff to re-open the long/river trail to the public in some capacity later this year.

HCWA Cubihatcha Fishing Tournament a sellout

The results of the Youth Fishing Tournament featured three winners with the largest Bass:

- 1st place – Coleman Selfe (the biggest catch of the day)
- 2nd place – Colton Turner
- 3rd place – Madison Harp

The contestant who caught the largest Crappie was Cannon Smith. Runners up in the bass fishing category were Nolan Randolph, Chase Holder, Chase Phillips, Drake Laney, and Kaleb Nation.

Participants enjoyed fishing for their bass and crappie on the 277-acre Long Branch/James H. Roland Reservoir, which is one of five reservoirs within the network of HCWA water resources used for drinking water production.

HCWA customers are invited to take advantage of the 2014-15 hunting season at the Cubihatcha Outdoor Education Center. The Authority staff at Cubihatcha has a few supervised hunts already scheduled, in hopes to build upon the success of the four public hunting events that were held this past season. All applications for the scheduled hunts are due in August.



The following hunts are scheduled for this year:

- September 27, 2014 – Youth Goose Hunt at the Tussahaw Reservoir and Tussahaw Island Public Use Area.
- October 4, 2014 – Youth Archery Deer Hunt at the Cubihatcha Center.
- November 8, 2014 – Youth Shotgun Deer Hunt at the Cubihatcha Center.
- November 29, 2014 – First Waterfowl Fundraiser Hunt.
- January 17, 2015 – Second Waterfowl Fundraiser Hunt.

Hunting applications due in August

All hunts on HCWA properties are held in compliance and under the supervision of the Georgia Department of Natural Resources. Applications, including necessary licenses and waivers, are required by the HCWA Cubihatcha Outdoor Education Center, located at 100 Collins Road in Locust Grove.
