

HCWA Youth Deer Hunt General Information for 2017:



Step 1: Applications can be found on hcwa.com website or may be picked up at Cubihatcha Outdoor Center in person on Monday – Friday between 8:00am – 4:00 pm starting on Monday, June 12th, 2017.

Step 2: Fill out application. Information provided will serve as contact information about the hunt so please print neatly and use accurate information. Make copy of driver's license or water bill as proof of Henry Co. residency.

Step 3: Return application with proof of qualifications by email to jeffrey.scott@hcwa.com or fax to 678 583-2106. You may also bring applications to Cubihatcha Outdoor Center in person with proof of qualifications during the following dates/times **ONLY!**

Monday – Friday June 13th – August 18th 8:00 am – 4:00 pm

No applications will be received after Friday, August 18th at 4:00pm

Drawing will be held at Cubihatcha Outdoor Center on Monday, August 21st at 2:00 pm.

Important information for those applicants who are drawn for the hunt:

1. It is **mandatory** that all applicants who are drawn for the Oct. 14th Youth Shotgun Deer hunt must call 678-583-3930 on or before Monday, October 9th between 8:00am – 4:00pm to confirm their spot. If drawn for October 28th Youth Shotgun Deer Hunt please call on or before Monday, October 23rd between 8:00am – 4:00 pm to confirm spot.
2. It is **mandatory** that all applicants who are drawn for either Youth Deer hunt attend an orientation meeting at HCWA LAS Building, 570 River Road, McDonough, Ga. 30252 at 6:00 pm the Friday before hunt. Meeting will take place at the River Road LAS Building.
3. All blinds will be provided; however, applicants are responsible for providing all other hunting equipment (shotgun, ammo, chairs, camo, etc.), and should bring these materials and be prepared the day of hunt. HCWA staff will transport hunters to and from their hunting locations. Hunters are responsible for removing all trash and materials immediately after the hunt.



2017 Release and Application Regarding Youth Deer Hunting on Henry County Water Authority Property:

Regulations for Youth Deer Hunting

The undersigned Deer Hunter, that the Henry County Water Authority is allowing the undersigned to become a participant in a managed hunt(s) of White-tailed deer on property belonging to the Henry County Water Authority, the undersigned does hereby release and discharge the Henry County Water Authority, its officers, directors, management, employees, and members of the Board of the Henry County Water Authority, of and from, any and all claims arising out of or by virtue of the undersigned being allowed to deer hunt on property of the Henry County Water Authority. This release is executed by the undersigned, for and on behalf of the undersigned, his or her heirs, successors, representatives or assigns, and is intended to be a full and complete release of the Henry County Water Authority of any and all claim that the undersigned may now or hereafter have against the Henry County Water Authority arising out of, or in any way connected with the undersigned's presence on the property of the Henry County Water Authority for purposes of participating in a managed deer hunt(s).

The undersigned acknowledges that he/she is a mere licensee whose right to remain on the property of the Henry County Water Authority is terminable at will and without notice. The undersigned agrees to vacate the property at such time(s) as the Henry County Water Authority or its representative in sole discretion determines is appropriate.

The undersigned expressly assumes all risks and damages incidental to the White-tailed deer managed hunt(s) conducted on the property of the Henry County Water Authority. The undersigned agrees and stipulates that the Henry County Water Authority, its officers, agents, employees, and Board Members are not responsible or liable for any injuries sustained and does hereby release any claim against them arising directly or indirectly from any such injury.

As evidenced by the below signature the signee has read and agrees to abide by the above release and all regulations governing the hunts on Authority Property to include both State Law and special regulations set by the Henry County Water Authority.

1. Hunters are responsible to insure that they have the proper license; all State laws and license are enforced and required.
2. Shotguns will be permitted for Youth Shotgun Deer hunts (Oct. 14th and Oct. 28th) only.
3. Youth must be between 10-17 years old.
4. *Only deer may be harvested.* Buck or Doe of choice.
5. Hunters must use personal state issued deer tags.
6. Alcoholic beverages are not permitted on Authority property.
7. Hunters must remain in designated area for duration of hunt. HCWA staff will escort hunters in and out of hunting area.
8. All hunters are required to have a working cell phone.
9. All hunters are required to wear 500 sq. Inches of orange above the waist at all times.
10. All hunting locations are assigned by lottery and hunters will be taken to and picked up from their hunting locations by HCWA staff.
11. Only Ground blinds will be allowed for this hunt. Blinds will be provided and set up by HCWA staff prior to hunt.
12. All deer must be brought to the check station before field dressed by the hunter.
13. NO tracking of deer will be allowed without accompany of HCWA staff member.
14. Any hunter who violates state law or special regulations set forth by the Henry County Water Authority is subject to losing their hunting privileges on Authority property, which will result in forfeiture of the hunt.
15. All trash /litter must be self-contained and disposed of properly. Littering is prohibited.
16. By signing the waiver, I hereby grant HCWA and their representative's permission to take and publish photographs of me at this event.
