

# 2017 HCWA Youth Dove Hunt General Information



**Step 1:** Applications can be found on [hcwsa.com](http://hcwsa.com) website or may be picked up at Cubihatcha Outdoor Center in person on Monday – Friday between 8:00am – 4:00 pm starting on Monday, June 12<sup>th</sup>, 2017.

**Step 2:** Fill out application. Information provided will serve as contact information about the hunt so please print neatly and use accurate information. Make copy of driver's license or water bill as proof of Henry Co. residency.

**Step 3:** Return application with proof of qualifications by email to [jeffrey.scott@hcwa.com](mailto:jeffrey.scott@hcwa.com) or fax to 678 583-2106. You may also bring applications to Cubihatcha Outdoor Center in person with proof of qualifications during the following dates/times **ONLY!**

Monday – Friday June 12<sup>th</sup> – August 7<sup>th</sup> 8:00 am – 4:00 pm

**\*No applications will be received after Monday, August 7<sup>th</sup> at 4:00pm\***

Drawing will be held at Cubihatcha Outdoor Center on Wednesday, August 9<sup>th</sup> at 2:00 pm.

## Important information for those applicants who are drawn for the hunt:

1. It is **mandatory** that all applicants who are drawn for the September 2, 2017 Youth Dove hunt call 678-583-3930 on or before Monday, August 28<sup>th</sup> 2017 between 8:00am – 4:00pm to confirm their spot.
2. It is **mandatory** that all applicants who are drawn for the Youth Dove hunt attend an orientation meeting at the Pullin Road Field at 10:00am the day of hunt. (Map with directions will be provided for those selected to hunt.) Meeting and Lottery drawing will take place at HCWA Dove field. Lunch will be provided for this hunt.
3. All applicants who are drawn for the Dove hunt are responsible for providing their own hunt materials (shotgun, shells, folding chairs, ground blinds, etc.), and should bring these materials and be prepared to set up their spot after the orientation meeting. HCWA staff will transport hunters to their hunting locations. Hunters are responsible for removing all blinds and materials immediately after the hunt.



**2017 Release and Application Regarding Youth Dove Hunting on Henry County Water Authority Property:**

**Regulations for Youth Dove Hunting**

The undersigned Dove Hunter, that the Henry County Water Authority is allowing the undersigned to become a participant in a managed hunt(s) of mourning Dove on property belonging to the Henry County Water Authority, the undersigned does hereby release and discharge the Henry County Water Authority, its officers, directors, management, employees, and members of the Board of the Henry County Water Authority, of and from, any and all claims arising out of or by virtue of the undersigned being allowed to dove hunt on property of the Henry County Water Authority. This release is executed by the undersigned, for and on behalf of the undersigned, his or her heirs, successors, representatives or assigns, and is intended to be a full and complete release of the Henry County Water Authority of any and all claim that the undersigned may now or hereafter have against the Henry County Water Authority arising out of, or in any way connected with the undersigned's presence on the property of the Henry County Water Authority for purposes of participating in a managed dove hunt(s).

The undersigned acknowledges that he/she is a mere licensee whose right to remain on the property of the Henry County Water Authority is terminable at will and without notice. The undersigned agrees to vacate the property at such time(s) as the Henry County Water Authority or its representative in sole discretion determines is appropriate.

The undersigned expressly assumes all risks and damages incidental to the Dove hunt(s) conducted on the property of the Henry County Water Authority. The undersigned agrees and stipulates that the Henry County Water Authority, its officers, agents, employees, and Board Members are not responsible or liable for any injuries sustained and does hereby release any claim against them arising directly or indirectly from any such injury.

*As evidenced by the below signature the signee has read and agrees to abide by the above release and all regulations governing the hunts on Authority Property to include both State Law and special regulations set by the Henry County Water Authority.*

1. Hunters are responsible to insure that they have the proper license; all State laws and license are enforced and required.
2. Shotguns will be permitted for the Youth Dove Shotgun hunt (Sept. 2<sup>nd</sup>) only.
3. Youth hunters must be between 10-17 years old.
4. *Only dove may be harvested.* Limit is 15 per hunter.
5. HCWA staff will hold a lottery drawing before the hunt to allocate hunting sites on managed fields.
6. Hunters will need to provide their own blinds and equipment and are also responsible for removing all blinds and equipment immediately after the hunt.
7. Hunters must check in and out at designated area.
8. All firearms must be unloaded during transport to and from assigned hunting area.
9. All hunters are required to have a working cell phone.
10. Youth must be accompanied by adult at all times.
11. Safety first! Absolutely no shooting of low birds!
12. Pre-hunt scouting of field may be allowed but only on specified date and time.
13. Any hunter who violates state law or special regulations set forth by the Henry County Water Authority is subject to losing their hunting privileges on Authority property, which will result in forfeiture of the hunt.
14. All trash /litter must be self-contained and disposed of properly. Littering is prohibited.
15. Alcoholic beverages are not permitted on Authority property.
16. By signing the waiver, I hereby grant HCWA and their representative's permission to take and publish photographs of me at this event.
