


HCWA Veterans Deer Hunt General Information for 2017

Hunt to Be Held Friday November 10th, 5:00 AM-11:00 AM and 3:00 PM till Sunset

THIS HUNT IS OPEN TO ALL Henry County Veterans

Who Have Been Honorably Discharged



Step 1: Applications can be found on hcwa.com website or may be picked up at Walnut Creek WRF, 1682 N. Ola Rd., McDonough GA. 30252 in person on Monday – Friday between 9:00 AM – 4:00 PM starting on Monday, July 10, 2017.

Step 2: Fill out application. Information provided will serve as contact information about the hunt so please print neatly and use accurate information. Make copy of driver's license or water bill as proof of Henry Co. residency. We will need a copy of your DD 214.

Step 3: Return the application with proof of qualifications by email to shelley.bogges@hcwa.com or fax to 770-305-9140. You may also bring applications to Walnut Creek WRF, 1682 N. Ola Rd., McDonough GA. 30252 in person with proof of qualifications during the following dates/times **ONLY!**

No applications will be received after Friday, August 25, 2017 at 4:00pm

Drawing will be held at Walnut Creek WRF, 1682 N. Ola Rd., McDonough GA. 30252 on Wednesday, August 30 at 9:00 AM.

Important information for those applicants who are drawn for the hunt:

1. It is **mandatory** that all applicants who are drawn for the hunt attend an orientation meeting at Walnut Creek LAS, 570 River Rd., McDonough GA. 30252 on Thursday, November 9, at 6:00 PM.
2. All applicants who are drawn for the hunt are responsible for providing their own hunting materials (orange hunting vest, shotgun, ammunition, hunting stool, etc.). HCWA staff will transport hunters to and from their hunting locations. Blinds are provided by HCWA.
3. You will be notified by email and /or phone that you have been chosen for the hunt. We will also pick 10 alternates to fill a position of someone who for some reason can't participate in the hunt. Those alternates will also be notified that they have been chosen as alternates. If you are chosen for the hunt and for some reason can't participate, please let us know ASAP.

Release and Application Regarding Hunting on Henry County Water Authority Property:

The undersigned Deer Hunter that the Henry County Water Authority is allowing the undersigned to become a participant in a managed hunt(s) of White-tailed deer on property belonging to the Henry County Water Authority, the undersigned does hereby release and discharge the Henry County Water Authority, its officers, directors, management, employees, and members of the Board of the Henry County Water Authority, of and from, any and all claims arising out of or by virtue of the undersigned being allowed to deer hunt on property of the Henry County Water Authority. This release is executed by the undersigned, for and on behalf of the undersigned, his or her heirs, successors, representatives or assigns, and is intended to be a full and complete release of the Henry County Water Authority of any and all claim that the undersigned may now or hereafter have against the Henry County Water Authority arising out of, or in any way connected with the undersigned's presence on the property of the Henry County Water Authority for purposes of participating in a managed deer hunt(s).

The undersigned acknowledges that he/she is a mere licensee whose right to remain on the property of the Henry County Water Authority is terminable at will and without notice. The undersigned agrees to vacate the property at such time(s) as the Henry County Water Authority or its representative in sole discretion determines is appropriate.

The undersigned expressly assumes all risks and damages incidental to the White-tailed deer managed hunt(s) conducted on the property of the Henry County Water Authority. The undersigned agrees and stipulates that the Henry County Water Authority, its officers, agents, employees, and Board Members are not responsible or liable for any injuries sustained and does hereby release any claim against them arising directly or indirectly from any such injury.

As evidenced by the below signature the signee has read and agrees to abide by the above release and all regulations governing the hunts on Authority Property to include both State Law and special regulations set by the Henry County Water Authority.

Regulations for Deer Hunting

1. Hunters are responsible to insure that they have the proper license; all State laws and license are enforced and required.
2. Walnut Creek veterans hunt will be shotgun only, using only buckshot ammunition.
3. *Only deer may be harvested.* You will be allowed to harvest 1 buck.
4. Hunters must use personal state issued deer tags.
5. Alcoholic beverages are not permitted on Authority property.
6. Hunters must remain in designated blind for duration of hunt. HCWA staff will escort hunters in and out of hunting blind.
7. All hunters are required to have a working cell phone.
8. All hunters are required to wear 500 sq. Inches of orange above the waist at all times.
9. Hunting areas will be assigned by lottery. Areas will be designated by Authority Staff.
10. No pre-hunt or post hunt scouting. Hunting is allowed only on specified date and times.
11. Only Ground blinds will be allowed for this hunt. All blinds will be pre-set and provided.
12. All deer must be brought to the check station before field dressed by the hunter.
13. NO tracking of deer will be allowed without accompany of HCWA staff member.
14. Any hunter who violates state law or special regulations set forth by the Henry County Water Authority is subject to losing their hunting privileges on Authority property, which will result in forfeiture of the hunt, entry fee, and any future hunting opportunity on Authority property.
15. Any lost and found or illegal hunter equipment found on Authority property is to be turned over to Henry County Water Authority or Dept. of Natural Resources personnel.
16. The Henry County Water Authority is not responsible or liable for loss, theft, damage or destruction of any person's personal property.
17. All trash /litter must be self-contained and disposed of properly. Littering is prohibited.
